Hence you are hereby directed to enter into an agreement with Sports Authority of India, SAG Centre, Kokrajhar on Non-Judicial Stamp Paper of Rs.100/- only in the form specified in Annexure -IX of the Tender document within 15 days from the date of issue of this letter of offer.

1. As per Tender documents the contract will be initially for a period of one year which may be extended for another one year if your service is found satisfactory.
2. The monthly contract value will be Rs. **119040/-** (Rupees one lakh nineteen thousand and forty only) inclusive of all taxes & EPF, ESI contributions etc.
3. In order to avoid any litigation in future, you are to maintain all registers pertaining to Security Guards/other services as per labor laws act and have to be shown to SAI officer in demand.
4. You have to follow all rules under the labor laws Act.
5. During the contract period, if your services are not found satisfactory, your contract will be liable for discontinuation by giving one month advance notice.
6. As per the terms and conditions of contract, you are required to furnish a performance security with 10 days of receipt of this letter for 10% of the total value of contract in the form of account payee DD, Fixed Deposit receipt or Bank Guarantee as per Annexure-X in favor of In-charge, Sports Authority of India, SAG Centre, payable at Kokrajhar.
